Learning Objectives

SAMBA 2012 Annual Meeting Goals - General

As the complexity of healthcare in the outpatient arena increases, the availability of on-site resources to help care for the patient with complex medical problems undergoing basic to highly innovative procedures has not followed suit. As a result, it is increasingly important for the anesthesiologist to evolve into the consummate perioperative physician. In addition, issues of quality, patient safety and regulatory compliance implemented in the hospital setting and showed decreased morbidity and mortality are now being addressed at the forefront of ambulatory practice. The overall goal of this annual meeting is to provide the anesthesiologist with the knowledge and tools necessary to independently care for the increasingly complex patient in the ambulatory setting.

General Session 1: Guidelines and Research

Attendees will be able to describe specific patient guidelines for four specific clinical areas of ambulatory anesthesia, including 1) glycemic control, 2) postoperative nausea and vomiting, 3) obstructive sleep apnea (OSA)-diagnosis; and 4) OSA- patient selection. In addition, attendees will be able to describe innovative ambulatory anesthesia research projects being funded through SAMBA.

General Session 2: Pediatrics

The attendee will be able to identify significant coexisting diseases in pediatric patients and their implications in the ambulatory surgery setting. In addition, participants will be able to list characteristics that comprise the ideal pediatric ASC environment and compare these to their own workplace. Lastly, attendees will identify scenarios for utilizing regional anesthesia in this patient population.

General Session 3: Geriatrics

The participant will be able to describe important demographic and physiologic factors of an aging U.S. population in the context of ambulatory anesthesia. In addition, attendees will identify important elderly patient selection criteria for ambulatory surgery, as well as distinguish key pharmacotherapy considerations in this patient population.

General Session 4: Practice Management

Attendees will be able to identify opportunities for improving workplace efficiency in the ambulatory surgery setting. In addition, participants will recognize major facets for current healthcare reform and how it may impact their clinical practice. Attendees will be able to describe what not to say or do when undergoing an accreditation survey at their facility. Lastly, participants will recognize important practical points in establishing and maintaining an office based anesthesia practice.

Learning Objectives

General Session 5: Current Clinical Challenges-Intersection of Medicine, Technology and Culture

Participant will be able to list major benefits of using an automated information management system in the ambulatory setting as well as how information derived from an AIMS can be used. Also, participants will be able to compare and contrast the various implantable patient devices currently used and what are the strategies for managing them are in the ambulatory setting. Lastly, attendees will be able to list the pro and con reasons for not using an airway device in the prone anesthetized patient.

General Session 6: Patient Safety and Outcomes

The attendee will be able to assess whether or not a culture of safety exists within their workplace, as well as what benefits a culture of safety provides. Also, participants will be able to recognize whether current perioperative data reporting is reflective of patient outcomes.

General Session 7: Sedation Guidelines, Rules and Must Do's

Participants will be able to identify both CMS and other accreditation organizational requirements in the ambulatory setting. In addition, the attendee will be able to apply practical applications of CMS and Joint Commission regulations for GI endoscopy service while maintaining patient throughput. Lastly, the participant will be able to list important sedation issues in the ASC and compare and contrast these to sedation safety issues in the office based setting.

General Session 8: Journal Club

Attendees will be able to compare and contrast recent pertinent literature for ambulatory anesthesia from leading high impact scientific publications and be able to integrate this information into their daily practice.

Lecture Series – Novel Airway Device Applications

The participant will be able to contrast the various supraglottic airway devices available enabling appropriate selection in a variety of settings. In addition, participant will be able to describe new technologies and their applications in airway management as well as list several new concepts in airway management.

SAMBA Frontiers Lectureship: Balancing Tricks, Bubbles and Mini-Pigs: Steps Along the Road to the Introduction of Propofol

Participants will be able to describe the development and eventual introduction into clinical practice of the most widely used anesthetic agent in the world.

State of the Art: The ASA Closed Claims Project and Lessons Learned about Ambulatory Anesthesia

The attendee will be able to summarize the role and impact of the ASA Closed Claims Project on profiling the anesthesiologist's professional liability, and more specifically what has been extrapolated to the field of ambulatory anesthesia.

ASA Update

Attendees will be able to relate the American Society of Anesthesiologists' role in an educational, research and scientific association of physicians and delineate how practitioners can use its resources to enhance their patient care and professional activities.

Cases From the Real World

Participants will be able to examine actual case scenarios and integrate various methods of care and strategies for preclinical problem solving for ambulatory surgical patients into their ambulatory practice.

Resident Session

Resident participants will be able to compare and contrast medical direction versus medical supervision of anesthesia providers. In addition, attendees will be able to discuss the impact of healthcare reform on their future careers after completion of training. Lastly, participants will be able to differentiate different practice types when considering employment as well recognize important practice attributes to consider prior to signing a contract.

PBLD

Participants will be able to better discuss and critique the evaluation, management and implementation of care in specific ambulatory clinical scenarios.

Excellence and Innovation: Abstract Presentations

Participants will be able to describe focused ambulatory anesthesia knowledge as presented by scientific abstract awardees.

Hands On Workshop: Introduction to Ultrasound in Anesthesia

The attendee will be able to demonstrate basic techniques for peripheral nerve blocks; discuss strategies for their successful perioperative management; describe common or serious complications and how to avoid them.

Hands On Workshop: Advanced Regional Catheters with Ultrasound

The participants will be able to demonstrate advanced techniques for peripheral nerve blocks utilizing regional catheters for ambulatory anesthetic management, as well as discuss postoperative pain relief for upper and lower extremity procedures. Anesthesiologists with minimal experience in regional anesthetic techniques should not enroll in this workshop.

Discussion Workshop: OBA – Emergencies

Participants will be able to discuss less common, but frequently devastating clinical emergencies that can occur in the office-based setting. Attendees will be provided with a template for each clinical scenario and will be able to construct an emergency plan that can be integrated into their practice.


